Walthall Honored by Samford with Macon Award

Cumberland School of Law Professor Howard P. Walthall recently received a top Samford University faculty award.

The George Macon Memorial Award for outstanding performance as a teacher, counselor and friend who inspires students to greatness was

presented to Walthall at the spring semester opening convocation on Tuesday, January 26. Samford President Andrew Westmoreland presented Walthall with a \$1,000 cash prize, and a [video](#) presentation highlighted his service and dedication to the university.

Walthall, who has taught at the law school for 40 years, was cited for his teaching, innovation, energy and devotion to students. He has taught an array of

courses, including first-year contracts, federal and state constitutional law, numerous business and commercial law courses, and cultural perspectives in the Samford undergraduate core curriculum. He has won the law school's Harvey S. Jackson Excellence in Teaching Award multiple times.

By pioneering the integration of writing instruction and assessment processes into classes and addressing a need for essential analytical skills, he continues to develop new approaches to meet the unique needs of students — making the law school program better for each new generation of students.

His tribute to the legend of Rascal, a dog that was awarded the degree of canine jurisprudence when Cumberland School of Law was located in Tennessee, is a popular part of the law school's annual Rascal Day celebration. He is also a longtime participant and organizer of Samford's Old Howard 100 bike ride held each spring.

Walthall is a magna cum laude graduate of Harvard College and a graduate of Harvard Law School. Before joining the Cumberland School of Law faculty, he was a partner in a Birmingham law firm.

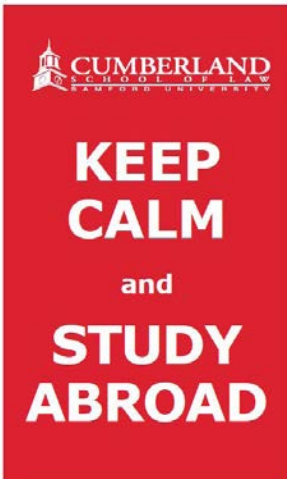

Bar Review Course Arrangements Finalized for Class of 2016

The law school has made arrangements with BarBri, Kaplan, and Themis in order to help students pay for bar review courses. This year's 2016 graduates may take review courses with one of these three vendors for a total cost of \$1300 plus applicable book deposits, taxes and shipping. Books, taxes and shipping fees are NOT part of the tuition charges.

To assist students in making a bar review vendor decision, Cumberland has planned informational meetings to allow BarBri, Kaplan and Themis to describe their courses and services at the following times:

BarBri: Thursday, January 21 at 11 a.m. in Room 120.

Kaplan: Tuesday, February 2 at 10:30 a.m. in Room 118.

Themis: Wednesday February 3, 9 a.m. in Room 121.

Food will be served at all meetings.

After the meetings have been held, students will receive a survey to make bar review vendor choices. Students are not obligated to choose these vendors; however, please note that if you elect to take advantage of these arrangements with Kaplan, BarBri, or Themis by selecting one of these courses, the law school will be obligated to pay the vendor for your course and you will be obligated to pay the law school your share of the cost (\$1300).

On Sat., February 27, from 7:30 a.m. to 3 p.m., for the eighth year, Cumberland will join with attorneys and judges from the Birmingham area to participate in Project Homeless Connect 9! at the Boutwell Auditorium (1930 8th Avenue North, Birmingham, AL 35203). Last year, volunteers from all professions provided services to more than 650 homeless or near-homeless clients with issues ranging from misdemeanor criminal charges, social security and housing crises, to health and dental care.





Faculty Notes



Months ago the City of Huntsville Board of Zoning Adjustment issued a building permit for a residence. Richard Chesnut, the owner of a neighboring home (he's also a lawyer) thought the permit allowed the builder to build twenty feet too close to the street. He asked **Professor Joseph Snoe** to review the city ordinance and the local regulations. Snoe did and agreed with Chesnut. Chesnut asked Snoe to write his reasoning in an affidavit. Chesnut submitted the affidavit to the Court of Appeals, who misguidedly deferred to the City of Huntsville Board of Adjustment's interpretation. Chesnut appealed to the Alabama Supreme Court. The Alabama Supreme Court reversed the Court of Appeals and ruled in Chesnut's favor. The Alabama Supreme Court mentions Snoe and his "well-reasoned analysis" and quotes chunks of his affidavit, italicizing paragraphs of it for emphasis.



Professor Paul Kuruk's article "Regulating "Access to Traditional Knowledge and Genetic Resources: The Disclosure Requirement as a Strategy to Combat Biopiracy" was recently published in Volume 17 of the San Diego International Law Journal.
