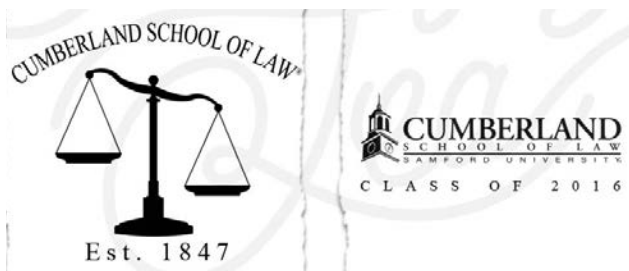

Elite Eight Selected in Williams Trial Competition

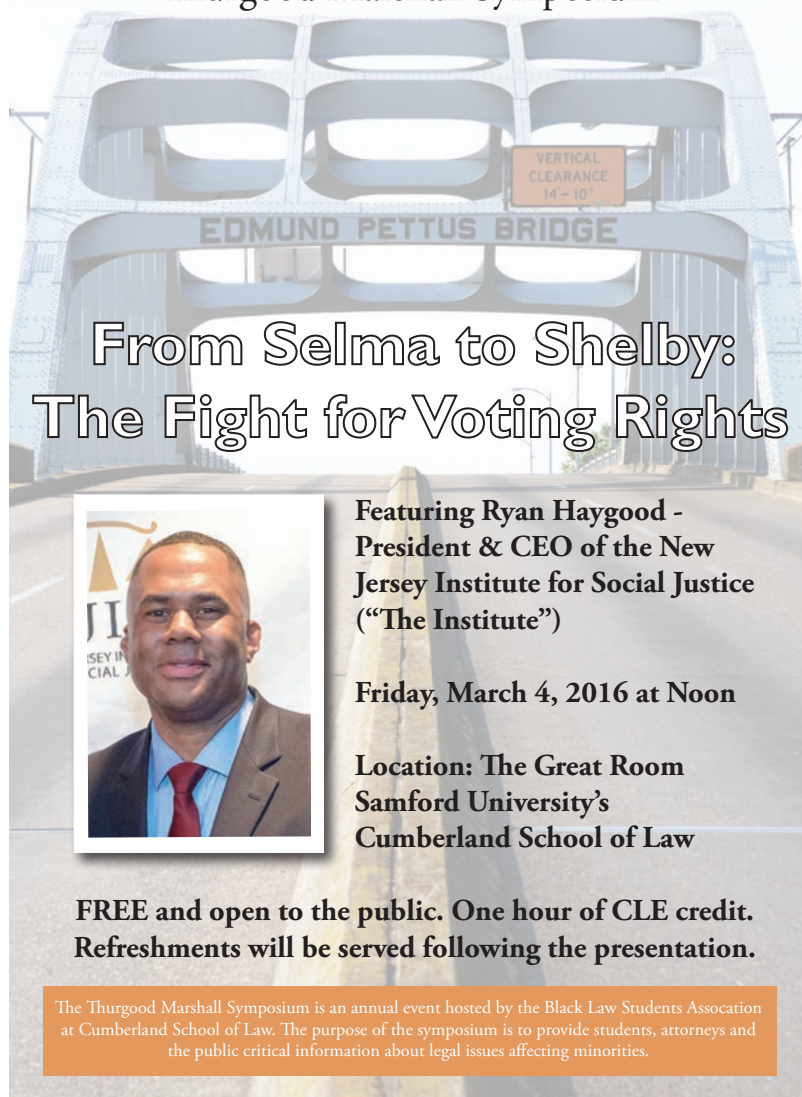
