2016 Daniel Austin Brewer Professionalism Award

During May commencement, the law school presented the annual Daniel Austin Brewer Professionalism Award to **Stewart Alvis**. The award, endowed by Governor Albert Brewer in honor of his father, is given to a member of the graduating class who most exemplifies the professionalism expected of Cumberland lawyers. Alvis was a member of the Cumberland Law Review, the National Trial Team and the Student Bar Association. While a student at Cumberland, he held various leadership positions including chief judge of the Cumberland Trial Advocacy Board.
